The regular meeting of the East Feliciana Parish Police Jury was called to order on September 20, 2021, at 6:00 P.M. by Police Jury President Louis Kent. President Kent offered an opening prayer and the Pledge of Allegiance was then led by Vice President O'Quin.

The roll was called by Parish Secretary Yamesha Harris and the following jurors were present: Mr. Michael Cheatham, Mr. Chris Hall, Mr. Ronald Johnson, Mr. Louis Kent, Mr. Jason McCray, Mr. Keith Mills, Mr. Richard Oliveaux, and Dr. Chrissie O'Quin. Mr. Kyle Fleniken was absent.

A motion was made by Mr. Keith Mills, seconded by Vice President Chrissie O'Quin, to approve the agenda and move the visitor's up. This motion passed unanimously without comment.

A motion was made by Mr. Ronald Johnson, seconded by Mr. Michael Cheatham, to adopt the minutes form the September 7, 2021 Regular Meeting. This motion passed.

A motion was made by Mr. Keith Mills, seconded by Vice President Chrissie O'Quin, to rescind September 1, 2021 motion selecting Rostan Solutions, LLC as the emergency debris company for standby contract for debris monitoring. This motion passed.

A motion was made by Mr. Chris Hall, seconded by Mr. Michael Cheatham, to adopt Design Exception Resolution for Project No. H.010562, Bank Street Bridge Over Lewis Creek. This motion passed.

Whereas, this resolution is for the purpose of acceptance of the Design Exception for the LA DOTD Project No. H.010562, Bank Street Bridge Over Lewis Creek;

Whereas, this is an Off-System Bridge Project on a Parish road that is a spot bridge replacement to replace a structurally deficient bridge structure;

Whereas, the existing bridge will be replaced by four (4) 10' wide x 8' tall x 44' long precast reinforced concrete box culverts with concrete headwalls;

Whereas, the proposed project will be 135' long, with minimal roadwork to include transitioning from the current 18' wide asphalt road to 20' wide asphalt road crossing the precast reinforced concrete box culverts and then transitioning back to the existing 18' wide asphalt road;

Whereas, the roadway functional classification is Rural Local, with a design ADT of 375 vehicles per day. This classification requires 2-foot wide aggregated shoulders; 4:1 fore slopes and 3:1 back slopes

Whereas, the East Feliciana Parish Police Jury does understand the design exception to not construct aggregate shoulders and allow the use of 3:1 fore slopes and 2:1 back slopes in lieu of 4:1 fore slopes and 3:1 back slopes for the 135' long project;

Therefore, let it be resolved by the East Feliciana Parish Police Jury to accept these design exceptions, as recommended by LADOTD for the Bank Street Bridge Over Lewis Creek, SPN H.010562
