A motion was made by Mr. Keith Mills, seconded by Vice President Chrissie O'Quin, to approve the agenda. This motion passed unanimously.

Mr. Kyle Fleniken asked Parish Manager Moreau for an update on sale of the Old DPW Building. Parish Manager Moreau informed Mr. Fleniken that an inspection would need to be done to see if the building could be moved.
