A motion was made by Mr. Keith Mills, seconded by Mr. Ronald Johnson, to approve the agenda and move the visitor's up. This motion passed unanimously.

A motion was made by Mr. Keith Mills, seconded by Mr. Jason McCray, to adopt the minutes from the February 7, 2022 Regular Meeting. Motion passed.

A motion was made by Mr. Keith Mills, seconded by Vice President Chrissie O'Quin, to table variance request for Mr. Kacie Schwartz to live in travel trailer for duration of residential house build at 5687 Highway 68. This motion passed. Mr. Schwartz was not present.

A motion was made by Mr. Jason McCray, seconded by Vice President Chrissie O'Quin, to table RV Park Presentation from Mr. Oscar Zerinque. This motion passed. Mr. Zerinque was not present.

Mr. Fleniken asked where does Haynes Street fall in the equation. Mr. McCray and President Kent informed Mr. Fleniken that Haynes Street is already approved. Mr. Hall informed the Jury that they would have to be patient. The cost of materials for an overlay project has increased and there is no guarantee that the funds could run out before each district is covered. Parish Manager Moreau informed the Jury that close to ten million dollars could be funneling into the Parish in three different grants this year and can be used for overlay projects. Mr. Moreau explained the funds could be used in different ways. Things such as drainage and asphalt would have to be divided
