### Sec. 12-87 – Definitions

Automobile wrecking yards- an approved building, structure, yard, or enclosure used for the demolition of vehicles in Louisiana

Junkyard/salvage yard- an approved building, structure, yard, or enclosure used for the purposes of storing junk or resalable vehicles or vehicle parts in Louisiana

Storage Area—an approved building, structure, yard, or enclosure used for the purposes of storing vehicles in Louisiana.

Storage Facility—any business or company that receives direct or indirect compensation for storing vehicles in Louisiana

## Sec. 12-109. - Light industry district (I-1) purpose/use.

- (a) District; designation and intent. Light industry. Any industrial use that creates little or no environmental or safety problems.
- (b) Permitted principal uses and structures. Wholesale and retail sales. Warehousing and light industry. Furnace repair; heating and air conditioning service; typewriter repair; sheet metal shops; plumbing shops; motor vehicle repair; automobile wrecking yards, junkyard, salvage yards and storage and towing facilities as defined and additionally regulated in 12-140; glass installation; new and used car sales; mini-storage garages; fabrication of gaskets and packing of soft and metal materials; creameries; bottling works; bus and truck terminals; parcel delivery service; bus and railroad

passenger terminals; truck terminals; drive-in theaters when approved by the department of highways; frozen food lockers; commercial stables; riding academy; animal hospital; auto repair; carpet cleaning; commercial auditoriums, coliseums or convention halls; bulk dairy products retail; dance halls; dog pound; dry cleaners and laundries; express office; fish market; private, gym, laboratory; farmers markets; motorcycle sales and repair, sheet metal shop; tire repair, upholstery shop; cemeteries and mausoleums, provided, however, that such uses shall be located on sites of at least twenty (20) acres, all graves shall be set back at least fifty (50) feet from all property lines, shall have a minimum street frontage of one hundred (100) feet and a fence or screen planting six (6) feet high shall be provided along all property lines adjoining all districts.

# Sec. 12-140. - Automobile wrecking yards, junkyard, <u>salvage yards and storage and towing</u> facilities.

The following regulations shall apply to all automobile wrecking yards, junkyards, salvage yards and storage and towing facilities: all yards and facilities shall comply with LAC 55:1901 et seq and La. R. S. 32:1712 et seq additionally No automobile wrecking yards, junkyards, salvage yards and storage and towing facilities shall be permitted closer than three hundred (300) feet to any property line of any agricultural or residential district. All outdoor storage of salvage and wrecking operations shall be conducted entirely within an enclosed solid fence or wall or chain link fence with slats. except driveway areas. Fences or walls shall be not less than ten (10) feet in height. Storage between such fence or wall and the street or property lines is expressly prohibited. Any fence or wall erected for screening purposes shall be properly painted or otherwise maintained in good condition. The fence or wall must be non-transparent. If greenery such as shrubs or trees is used, said greenery shall be of a variety to provide year-round non-transparent screening with a minimum height of at least ten (10) feet. The definitions found in LA R.S. 32:1 et seq., R.S. 32:1711 et seq. and LAC 55:1901 are applicable to these rules and shall have the same meaning indicated unless the context clearly indicates otherwise.

Every tow truck operator, towing or storage facility, employees or agents of a storage or towing facility, subject to or licensed in accordance with this Chapter shall comply with the laws of Louisiana, Federal Motor Carrier Safety Regulations, Federal Hazardous Materials Regulations, specifically, 49 CFR Parts 100 through 399, if applicable, and rules promulgated herein. None of the rules contained herein shall exempt a tow truck operator, towing or storage facility, its employees or agents from complying with law, rule or regulation
