Sec. 13-21. Governing body.

The gas utility district shall be governed by a board of five (5) commissioners, each of whom is a resident of, and a taxpayer on real property located in, the district. In accordance with the authority of R.S. 33:4303, members of this board shall serve initial and subsequent terms as provided by Subsection B of R.S. 33:4303, and thereafter serve a term of five (5) years.

Members shall be appointed as follows:

- (i) The governing authority of East Feliciana Parish shall appoint three (3) members
- (ii) The governing authority of Wilson shall appoint one (1) member
- (iii) The governing authority of Norwood shall appoint one (1) member
