The meeting called to order by Chairman O'Quin at 6:02 p.m.

Prayer was offered by Commissioner Anderson and the Pledge of Allegiance was said in unison.

Secretary John Rouchon called the roll. Chairman Josh O'Quin and Commissioners Shirley Anderson, Andy Bishop, Martin Macdiarmid, and Matthew Peterson were present. Commissioners Beau Cotton, Ashley Ferguson, and Debbie Odom were absent. A quorum was present.

A motion was made by Commissioner Peterson; seconded by Commissioner Bishop to approve the agenda. Motion carried unanimously without discussion.

A motion was made by Commissioner Bishop; seconded by Commissioner Peterson to approve the minutes for the 23 January 2024 Regular Meeting. The motion passed unanimously.

Old Business:

a. Dr. Dearl Sanders expressed his concerns regarding the Scott Barr/Frizzel outdoor shooting range. He was joined by his sister Susan Sanders and wife Brenda Sanders. Their concerns centered around the safety of the neighbors and the destruction of the area tranquility. Ben Fabre, Operator & Range Safety Officer, addressed their concerns by outlining the numerous layers of safety procedures practiced by every user of the range. Following his presentation the Chairman suspended further discussion on this issue until the other agenda items were completed.

b. The recommendation for the rezoning of 13804 Hwy 959 was tabled until the Commission received a drawing of the area to be rezoned and letter of intended use of the buildings. The motion to table was made by Commissioner Peterson; seconded by Commissioner Bishop. The motion carried.
