

The regular meeting of the East Feliciana Parish Police Jury was called to order on May 6, 2024, at 6:00 P.M. by Police Jury President Louis Kent. Opening prayer was offered by President and the Pledge of Allegiance was then led by Mr. Jason McCray.

The roll was called by Parish Secretary Yamesha Harris and the following jurors were present: Mr. Dexter Armstead, Mrs. Kristin Chasteen, Mr. Michael Cheatham, Mr. Kyle Fleniken, Mr. Louis Kent, Mr. Jason McCray, Mr. Richard Oliveaux, and Dr. Chrissie O'Quin. Mr. Keith Mills was absent.

A motion was made by Mr. Jason McCray, seconded by Mr. Michael Cheatham to approve the agenda with two additions. 1) Approval of contract with State for April Severe Storms Debris Removal. 2) George Turner Map recommendation (Planning & Zoning Commission). This motion passed unanimously.

A motion was made by Mr. Jason McCray, seconded by Mr. Dexter Armstead to adopt minutes from the April 15, 2024 Regular Meeting. Motion passed.

A motion was made by Mr. Jason McCray, seconded by Mr. Michael Cheatham to allow Housing Choice Vouchers in East Feliciana Parish. Vice President Chrissie O'Quin and Mrs. Kristin Chasteen opposed. Mr. Richard Oliveaux abstained. Motion passed

A motion was made by Vice President Chrissie O' Quin seconded by Mrs. Kristin Chasteen to approve \$25,000.00 Task Order with HGA for April Severe Storm. Motion passed.

A motion was made by Mr. Kyle Fleniken, seconded by Mr. Dexter Armstead to table accepting of proposal from Wright Construction Group at a rate of %5.25/CY funded by Solid Waste, to pick up debris at Vegetative Waste Site to haul, burn and disposal of ashes. Motion passed
