NAME CHANGE - \$10.00 (per meter)

- 911 address posted, in accordance with the ordinance
- Town Approval if residing within any of the town limits Clinton, Jackson, Norwood, Slaughter, Wilson
- If power has been turned off for two weeks or more and is not on a town sewer system, it must have an approval for the septic system from the Health Unit, 225.683.4148
- Once approved the meter is released to Demco or Entergy
- Jackson Square and Shadowbrook Apartments do not require Town approvals as they
 have their own water system.

CERTIFICATE OF USE/NAME CHANGE OVER 6 MONTHS - \$125.00 (per meter)

If power has been off for 6 months or more, it must have an approval for the septic system from the Health Unit, 225.683.4148 and an inspection by the Building Official. A list of items that the Building Inspector will be checking during inspection is available for pickup or can be emailed.

- 911 address posted, in accordance with the ordinance
- Town Approval if residing within any of the town limits Clinton, Jackson, Norwood, Slaughter, Wilson
- Approval for the septic from the Health Unit, 225.683.4148
- Safety inspection is scheduled after receipt of the environmental/Health Unit approval and is then performed by Building Official.
- Once approved by the Building Official, the meter is then released to Demco or Entergy

- Fire Marshal Review Report determining the kind of Commercial Occupancy along with the approved plans stamped by the Fire Marshal (if making changes to the occupancy/use or to the building) are required at time of permitting
- Approval for septic system from the Health Unit, 225.683.4148 (if not on town sewer)
- Safety inspection is scheduled after receipt of the environmental/Health Unit approval by Building Official.
